Heather Logelin, President & CEO of St. Croix Valley Foundation to discuss entering into a Foundation through their Foundation.

- -To start with their Foundation requires a \$10,000 initial contribution to get our found started through them.
- -No money will be paid out for the initial 12 months.
- -Annual payment out from the Foundation is 4.5%, with pre-paid fees of 1.5% up to \$500,000 into the Foundation, then a fee of 1.0% up to \$1,000,000 then after \$1 million has amassed in our fund in the Foundation the fee is 0.85%.
- -If HTOC were to fold or become defunct all remaining interest would go to perpetual care of the Cemetery and grounds
- -All money's placed into the St. Croix Valley Foundation are controlled by them, with only the residual 4.5% coming to HTOC.
- -An information presentation will be given during Adult Ed on May 12
