Pastor's Report 2025

What a grace-filled year we have concluded. Our parish celebrated three Baptisms, and a whopping *eleven* additional Chrismations in 2024. Amazingly, our roster of child members (*under 18 yrs*) rose from 30 to 41 in just one year's time – a 37% increase! And we continue to welcome a steady stream of beautiful visitors and inquirers, with several more Baptisms and Chrismations already scheduled for this spring.

We solemnized two burials on our grounds: Anne McDaniels, a daughter of this parish lost too young, and James Gleboff, grandson of former HTOC priest Gregory Gleboff. Holding their lives in love and grief, we celebrate the hope of the resurrection.

Adult Ed has been exploring the Sacraments of the Church. Everyone's questions, insights, and wisdom provide an ongoing blessing for myself and all who are present.

I again want to thank the parish for supporting my Spiritual Direction certification program, from which I graduated in April. Spiritual Direction focuses on helping a person be aware of the ways God is moving in their life, both in the big things and the little. Its goal is to empower a person to hear God's quiet voice within themselves. I currently see a handful of both parishioners and outside clients each month for Spiritual Direction. I know that in spite of all the challenges we face in our lives, we will continue to grow in love, in spirit, and in faith in Jesus Christ. It is my deepest desire that each of you continue to experience God dwelling within your wonderful self.

HTOC Endowment Fund update

Church membership voted at the 2024 annual meeting to investigate options for forming an endowment fund to aid parish's long-term financial stability and offer a choice for 'legacy' gifts.

After exploring several options with three law firms, we settled on a partnership with the Hudson-based *St. Croix Valley Foundation's* Agency Fund. SCVF already has some 90 non-profits as Agency Fund partners, including five area churches, including *Ezekiel Lutheran, Pilgrim Lutheran, Lakes United FC, Our Saviors Lutheran, St. Paul Episcopal.*

Our arrangement takes advantage of *SCVF*'s expertise in accepting complex gifts such as appreciated stocks, IRA distributions, real es-

tate, vehicles, bequests, life insurance, charitable gift annuities, and cryptocurrency. Management fees are less than 2 percent.

Beginning July 2025, Holy Trinity can access an annual dividend of at least 4 percent each year, if desired. The sum can be used to supplement our annual budget or spend it on special projects.

As of Dec. 31, 2024, Holy Trinity Endowment Fund totaled \$20,250 from three donor gifts.

It has been suggested that donor gifts and memories/*In Memory Of* inscriptions be recorded in a book, available for viewing in the library area. Nothing has been formally decided yet.

Gifts can be given anytime. Simply include a note that designates the gift to "HTOC Endowment Fund".
